I later went up to some of the people and introduced myself and said I was CalPac President. I asked why they felt that way about CalPac. The main point was it is difficult to attend meetings in California because of the distances we have to travel sometimes, and that agencies often don't support sending employees to Section meetings. One person I spoke to had in the past belonged to another section and enjoyed it, but didn't feel the same attraction to our section. I really feel upset about what I heard. I would just cast off what I heard as someone having a bad day, if it weren't that there were a half dozen or so involved in the conversation.

The question to me is: What can we do to enhance the positive aspects about CalPac and SRM to Range Professionals? I am perplexed by how to remedy the situation, particularly with agency staff. I know it is hard for staff to attend meetings when the agency doesn't support such attendance. In my case, I often will request government travel time without per diem, or just attend on my own time. I do think as professionals we have a responsibility to attend professional societies regardless of whether our employer will send us or not. I also understand the financial strain attending professional meetings can have on someone early in their career. In any event, somehow we need to be able to share the value of our society with range professionals who do not belong.

I wanted to write a more upbeat letter, but I think the reality is that we have an image problem with some range professionals and I think we need to work on our image. So I urge each of you when the opportunity arises to promote our society with Range Professionals.

On another note, I hope you are all planning on attending the spring meeting in Santa Rosa. It is going to be an exceptionally informative meeting. Hope to see you all there.

## Lost Resources: Robert W. Delzell

Robert "Bob" Delzell, age 73, died suddenly and unexpectedly on January 27 on an aortic aneurysm while exercising at a local fitness center in Los Osos, California. Born in Wyoming on September 9, 1935, Bob was the only son of James W. Delzell and Lucile B. Newcomer. As Bob loved to say "I was born in a horse barn, converted to a hospital along the Oregon Trail in Guernsey.

In 1938 the family moved to Denver. Except for two years in Dallas and Grand Prairie, Texas, Bob grew up in Colorado, graduating in 1954 from Englewood High School. "I played guard position on the first-string football team," and from that experience came lifelong friendships, a respect for teamwork, and in later years a willingness to bike and run, and a dedication to exercise.

Bob attended Colorado A&M in Fort Collins, graduating in Forestry and Range Management in 1958 just after the Aggies were renamed Colorado State University. He worked for the US Department of Agriculture, Soil Conservation Service (SCS) in Trinidad, Pagosa Springs and Pueblo before serving six years on Maui, Hawaii. In 1978, the family moved back to the Mainland where Bob was on loan from SCS to the Environmental Protection Agency in San Francisco. In July 1981 Bob became the State Resource Conservationist for SCS in Davis, California. He retired in 1990 after 33 years, two of which were spent back at CSU where he completed a Master's in 1968.

Bob was a life-long member of the Society of Range Management and the Soil and Water Conservation Society of America. In 1991 Bob was instrumental in starting a new organization, the California Native Grass Association.

Bob is survived by Kathleen, his wife of 50 years, by daughters, Deborah (Scott Liddell) of Denver, Ruth (Yildiz Batuk) of Aurora, and Rebecca (Michael Calhoun) of Green Valley, AZ, by six grandchildren, Sarah and Samuel of Denver, Jemal and Ibrahim of Aurora, Torin and Alana of Green Valley, and by sister, Evelyn Ann Delzell of Longmont. He is preceded in death by his parents and by grandson, Deniz Delzell Batuk. Additional information and photos can be found on:

#### Graduate Assistantship (PhD) available

A Graduate Research Assistantship (PhD) to study **Spatial Distribution of Livestock-Grazing in Semiarid Woodland / Grassland Ecotones** is currently available. We are seeking to attract a highly motivated individual interested in studying habitat selection and movement ecology of livestock. Although most of the field work will be conducted at modified woodland sites in central New Mexico and south-central Oklahoma, this project is part of a regional network that includes research sites in Argentina. Therefore the individual selected for this position will be expected to work with both U.S. and Argentine collaborators.

Applicants must have earned a Master of Science degree in Rangeland Ecology, Wildlife Science, Ecology, or a related discipline with a minimum 3.5 GPA. Outstanding writing skills and knowledge of GPS/GIS are required. Spatial data analysis skills and proven ability to publish in peer-reviewed journals are highly recommended.

Preferred starting date is August 1, 2009 but is negotiable. The assistantship includes an annual salary of US\$ 20,500.00, waiver of out-of-state tuition, health insurance benefit program, and the possibility of obtaining a tuition fellowship (waiver) from the Graduate School at New Mexico State University for highly qualified individuals. ### First Call for Symposium, Organized Oral Session, and Workshop Proposals

This is the first call for submission of proposals for symposia, organized oral sessions, and workshops for the 63<sup>rd</sup> Annual Meeting of SRM, being held jointly with the Weed Science Society of America (WSSA). Following are criteria for these events:

**Symposia** - provide scientific focal points to the annual meeting. They often cover topics of high or broad interest. Symposia contain presentations devoted to synthesis, as well as opportunities for discussion. It is expected that symposia will be published in some manner. Proposals for symposia will be peer-reviewed. In considering proposals, please take into account that a keynote joint SRM and WSSA symposium on invasives has already been scheduled.

**Organized oral sessions** - spotlight certain topics. Like symposia, speakers are arranged by the organizer. These sessions differ from symposia by either addressing subjects that have less scientific interest, lack an emphasis on synthesis, or when there is no intent to publish the proceedings. Proposals will be reviewed by the Program Committee.

**Workshops** - tend to be hands-on sessions that emphasize the exchange of ideas and the demonstration or application of skills pertaining to rangeland management. Proposals will be reviewed by the Program Committee.

**Proposals for symposia, organized oral sessions, and workshops are due by May 1, 2009.**

#### Proposals should include:

1. Type of event – symposium, organized oral session, workshop.
2. Title of event.
3. Name and contact information of the organizer.
4. Time needed (e.g., half day).
5. Names of presenters (if known).
6. Brief explanation of the topic's importance and intended audience.
7. Proposals for symposia should also include the name and type of intended proceedings outlet; e.g., peer-reviewed or not, printed or on-line.

**DEADLINE** - Abstracts for volunteer oral and poster papers, organized oral sessions, and symposia are to be electronically submitted no later than **1 September 2009** via [www.rangelands.org/denver2010/](http://www.rangelands.org/denver2010/). This site can be accessed through the WSSA webpage.

***Detailed criteria and instructions for submitting abstracts and their presentation are found on the web site.***

**PAPER PRESENTATION INFORMATION** - Volunteer papers will be presented within a 20-minute schedule; to allow for questions, you should plan to present your paper in 15 minutes. Concurrent sessions dictate that the time schedule be strictly followed. Papers and posters report the results of completed research or other substantive information. Technical sessions to which abstracts shall be submitted are posted on [www.rangelands.org/denver2010/](http://www.rangelands.org/denver2010/). PowerPoint will be used exclusively to project visual aids for all oral presentations. A Windows PC laptop computer and projector will be provided for each session. Presentations may be forwarded to the Section Chair prior to the meeting for pre-loading or directly uploaded from a memory stick in the hour prior to the Section itself.

**SYMPOSIA, WORKSHOPS AND ORGANIZED ORAL SESSIONS** - Symposia, workshops, and organized oral sessions are by invitation (see [www.rangelands.org/denver2010/](http://www.rangelands.org/denver2010/)). Deadlines and procedures for preparing and submitting abstracts are the same as for volunteer papers.

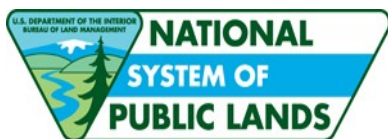

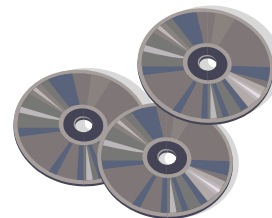
