- Promote the Endowment Fund through the SRM web site EFDC will work with OCW Committee and the web master to incorporate the Endowment Fund in a proactive manner within the SRM Web site. The Endowment Fund would have a button on the SRM home page and would promote giving to the Endowment Fund.
- Organize a silent auction for the annual meeting in Corpus Christi.

  - The EFDC recommends to the Board of Directors that all donors to the Society be recognized (not just donors to the EF) through a formal acknowledgement process.
  - The EFDC recommends that the Board of Directors request each SRM committee maintain a brief committee history that would be updated annually.
  - The Endowment Committee agrees with the recommendation of the Finance Committee regarding the calculation method for the Endowment Fund August contribution to the SRM operating account.
  - EFDC recommends that the Board of Directors create an "Endowment Fund button" on the SRM home page that directs users to the Endowment Fund webpage (<a href="http://www.rangelands.org/endowment/">http://www.rangelands.org/endowment/</a>) rather than the membership log-in.
  - In order to increase revenues by marketing the Society's accomplishments, EFDC recommends that the Board of Directors should identify Society activities that can be attributed to the annual Endowment Fund contribution to SRM.
  - Because of the unique circumstances of the Pendleton bequest to the Endowment Fund and because the BOD will have more significant donations in the future, EFDC recommends that the Board of Directors work with the EFDC to increase revenues by using a portion of the 8-1-15 EF distribution for the development of the new SRM web site.
